## Market Overview

Goldman Sachs Dynamic Opportunities Limited ("GSDO" or the "Fund") returned 0.64% net<sup>1</sup> in the month of July (for the USD share class).

Nine out of nineteen managers in the portfolio posted positive returns.

Two out of four Relative Value managers finished the month in positive territory. Long equity volatility and short-biased credit funds were the largest positive contributors to returns, as the month-end market correction benefited their defensive strategies. However, the equity market reversal hurt quantitative equity market neutral funds, due to sharp losses in some companies that sold off drastically despite strong fundamentals. One fund's equity stock selection model detracted from returns along with yield curve and M&A arbitrage strategies. Another fund focused on credit volatility trading experienced strong gains as CDS exposure contributed in a dramatically widening credit spread environment.

Two out of five Event Driven managers finished the month positive. Global equity and credit markets experienced substantial volatility as risk was re-priced and portfolios de-levered across all asset classes with trouble in the sub-prime mortgage space serving as a catalyst for the broader sell-off. Leveraged loans suffered dramatic declines as demand for structured credit declined severely and the market for leveraged buyout loans virtually disappeared. In this environment, one fund saw strong gains driven by short exposure to the credit markets, subprime and financials. Another fund experienced negative returns driven by long exposure to the auto sector.

Four out of seven Equity Long/Short managers were able to generate positive performance. Equity markets started off the month strong, but tumbled in the last ten days of the month on concerns about worsening credit conditions and fears that the global boom in leveraged buyout activity would abate. Energy and technology stocks were the best performing sectors in the U.S. Among the worst performing sectors were financials, healthcare, and retail. One fund benefited from short positions in the U.S. financial sector. An Asia-focused fund benefited from investments along the China financial reform and Taiwan property theme, while experiencing negative returns from its short positions.

Two out of three Tactical Trading managers experienced negative returns. Long equity exposures generated losses for funds as the major markets experienced sharp declines near month-end, emboldened by U.S. credit market concerns. Fixed income trading from the short side also saw negative results. Bond markets rallied in the second half of the month as losses in equities and other riskier assets sparked demand for high-quality government securities in a typical "flight to quality" scenario. For one fund, strong performance was primarily driven by fixed income and foreign exchange trading whilst emerging markets and commodities detracted. Another fund saw negative performance primarily from trend-following models, while commodities trading contributed positively to returns.

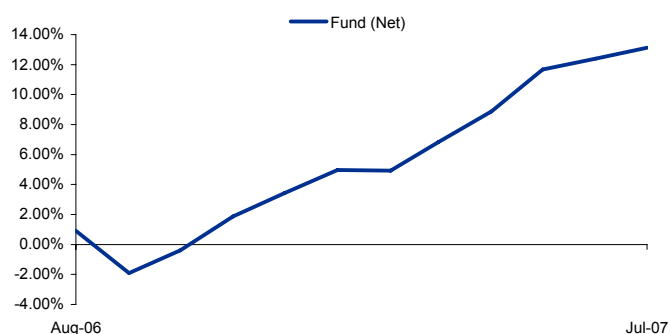

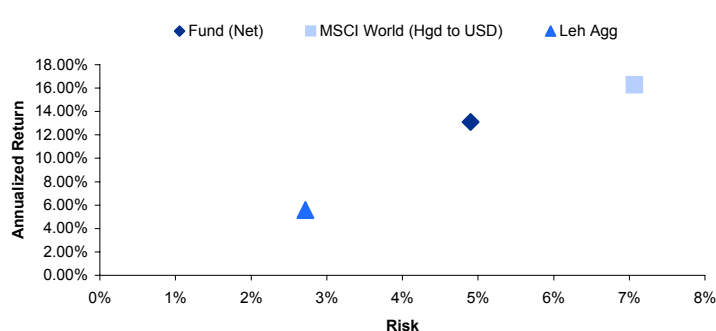

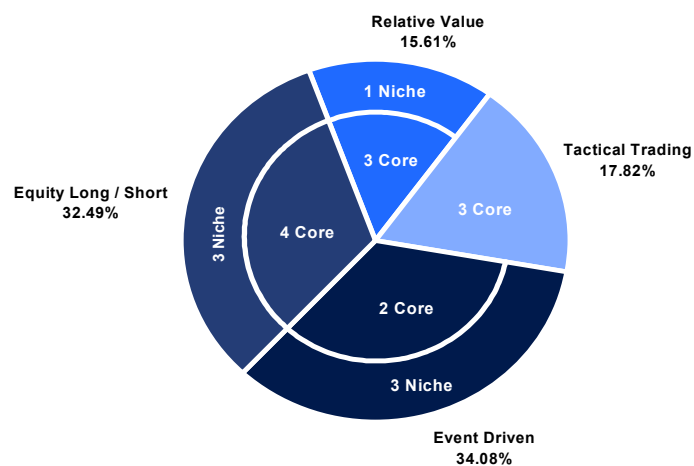

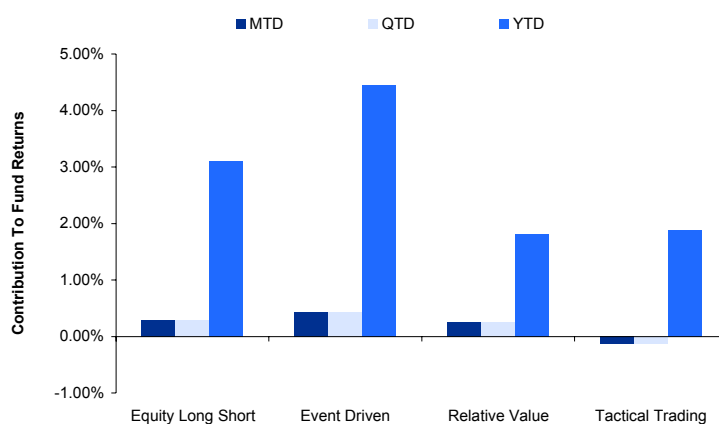

#### Effect of fees on performance:

The following table provides a simplified example of the effect of management and incentive fees on portfolio returns. For example, assume a portfolio has a steady investment return, gross of fees, of 0.5% per month and total management fees of 0.1250% per month of the market value of the portfolio on the last day of the month and incentive fees of 10% of net profits. Management fees and incentive fees are deducted from the market value of the portfolio on that day. There are no cash flows during the period. The table shows that, assuming that other factors such as investment return and fees remain constant, the difference increases due to the compounding effect over time. Of course, the magnitude of the difference between gross-of-fee and net-of-fee returns will depend on a variety of factors, and the example has been intentionally simplified.
