### Market Overview

Goldman Sachs Dynamic Opportunities Limited's ("GSDO" or the "Fund") underlying investments generated positive performance in May, posting a 3.45% gain (US Dollar, net of fees).

Seven of the eight managers in the Event Driven sector ended the month positively. The sector benefited from continued strength in both the equity and credit markets. Given the recent sustained rally in both the primary and secondary high yield and leveraged loan markets, credit managers generally performed well in the month as most were able to generate alpha from strong credit selection. Managers have been actively realizing gains as the rally has altered the risk/reward profile for many credits. Similarly, multi-strategy managers also experienced positive returns during May primarily due to strong performance in credit investments. Managers who have recently incorporated thematic commodities views in their portfolios saw an additional uptick in performance, largely driven by the broader commodities rally towards the end of May.

All of the Fund's five managers in the Equity Long/Short sector ended the month positively as the high beta rally in equities continued; virtually all positive contributors to performance were long positions and the majority of detractors were short positions. Top performing managers included those with the highest levels of net exposure, particularly to energy, materials, financials, healthcare, and emerging markets. Managers have modestly increased gross exposure as volatility has decreased and signs of economic stabilization have begun to appear. They see a number of opportunities on both the long and short sides of the portfolio and continue to actively trade portfolios as short-term opportunities appear and positions are quickly hitting price targets.

Three of the Fund's four Tactical Trading managers realized positive performance in May. The Fund's CTA manager experienced negative performance due to detracting long volatility positions in livestock and agriculture. Exposures to grains and softs also proved difficult, hurting on both the long and short side of the portfolio. The Macro managers were all positive, benefiting from short USD positioning, long select commodities, a steeper yield curve and moderately long equity exposure.

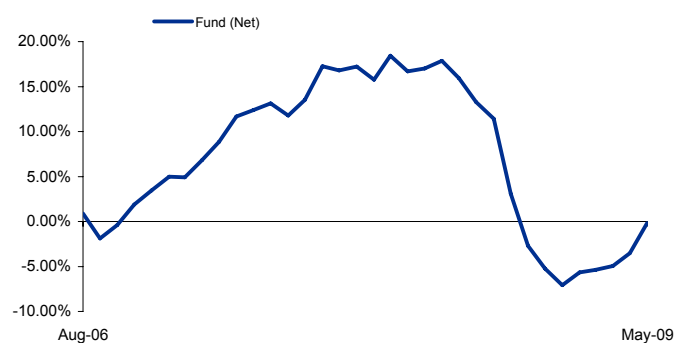

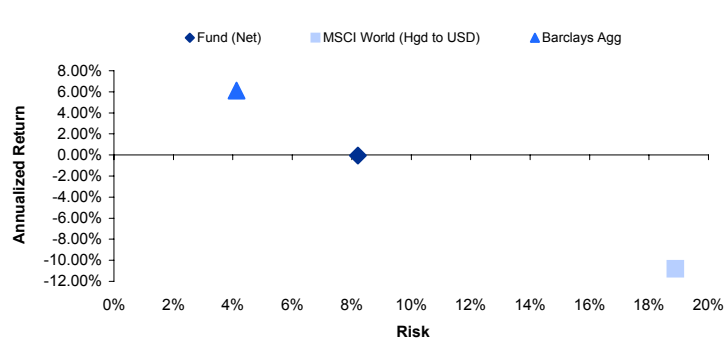

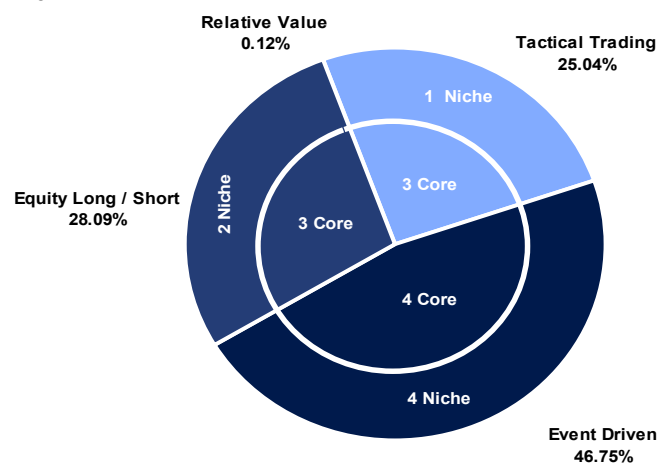

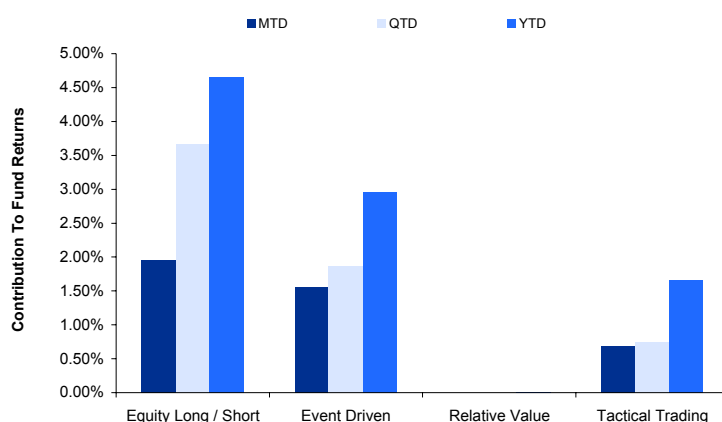

#### Effect of fees on performance:

The following table provides a simplified example of the effect of management and incentive fees on portfolio returns. For example, assume a portfolio has a steady investment return, gross of fees, of 0.5% per month and total management fees of 0.1250% per month of the market value of the portfolio on the last day of the month and incentive fees of 10% of net profits. Management fees and incentive fees are deducted from the market value of the portfolio on that day. There are no cash flows during the period. The table shows that, assuming that other factors such as investment return and fees remain constant, the difference increases due to the compounding effect over time.
